SUBJECT: NOTIFICATION OF PLANNED ASBESTOS ABATEMENT WORK AT YOUR SITE

An asbestos abatement response action is scheduled to be performed at your site. The Asbestos Hazard Emergency Response Act (AHERA) requires that school staff and parents or legal guardians of students be notified of asbestos abatement work. This work will be performed by certified asbestos abatement workers in a manner that ensures all environmental and safety regulations are observed. The work areas will be posted with asbestos danger signs, as well as be isolated from other areas of the building(s).

This abatement will be in: Kindergarten #1 (006DAL)

The work space(s) is: Restroom

The reason for the abatement is: Maintenance

The building material to be abated is: Floor sheeting

The abatement will involve the following: Removal of all Asbestos Containing Materials prior to installation of new flooring.

The anticipated start date is: December 15, 2023

The anticipated completion date is: December 17, 2023

After the abatement is completed, a detailed report will be sent to you. This report is to be inserted in the Asbestos Management Plan book, under the tab "ABATEMENT ACTIVITIES."

Please post this notice on your bulletin board for staff to read. In addition, the information above should be sent in a notice to the parents or legal guardians of the students, using the school's regular method of communication.

ASUNTO: NOTIFICACION SOBRE EL PLAN DE SUPRESION DE ASBESTO EN SU PLANTEL
